# **Agriculture Essay Contest Deadline is April 1**




Wisconsin fourth and fifth grade students are encouraged to participate in the Ag in Classroom essay contest answering the statement, 'Tell us

about cranberry production in Wisconsin during one of the four seasons.'

Essay submissions must be 100- to 300-words in length and will be judged on content, grammar, spelling and neatness. Contest rules, lesson plans and sample classroom activities are located at wisagclassroom.org. Participating students and schools need to submit essays by April 1. The essay contest coincides with the Ag in the Classroom 2017 Book of the Year, Time for Cranberries by Wisconsin author Lisl H. Detlefsen. The book and essay topic allows students to learn about cranberries and the important role they play in agriculture.

One county winner will be selected and will be forwarded to the district level. Each district winner will receive a classroom presentation in May for their homeroom or class. A state winner will



be selected from nine district winners in May by the Wisconsin Farm Bureau Foundation's Promotion and Education Committee.

As a special treat for the state winner this year, the author

of the book will visit his or her classroom to do a special presentation.

Last year, more than 3,000 students participated in the contest. The contest is sponsored by Insight FS, We Energies and the Wisconsin Farm Bureau

Ag in the Classroom is designed to help students in kindergarten through high school to understand the importance of agriculture. It is coordinated by the WFBF in cooperation with the U.S. Department of Agriculture and with a grant from the Wisconsin Department of Agriculture, Trade and Consumer Protection.

"The Institute gives participants the skills and confidence necessary to lead the future of farming and agriculture in their county Farm Bureau, local community and beyond."

The Institute consists of five multi-day sessions that provide hands-on learning on issues important to agriculture, development of leadership and speaking skills, interaction with Farm Bureau and governmental leaders and staff at the state and national levels and networking with other participants.

The first session begins in January and

focuses on public speaking, etiquette, emotional intelligence and personality types. Subsequent sessions focus on



media and advocacy training, running effective meetings, the structure and function of Farm Bureau, being a creative leader, the workings of local and state government and future national and international ag issues.

The class capstone event is a joint trip with the WFBF Board of Directors to Washington, D.C., in April of 2018.

Before I begin, however, I want to thank my board of directors. Our county Farm Bureau is run by a dedicated volunteers who meet

regularly each month and are committed to conducting programs and activities that support the agricultural community

The Fond du Lac County Farm Bureau is dedicated to supporting the agricultural youth in the county. This year the board made a donation to the Friends of 4-H endowment fund, and made donations to several of the FFA chapters for their day on the farm events.

Aaron VanRuiswyk, a graduate of Waupun High School, was awarded a \$500 scholarship. The board also made its annual contribution of \$1,000 to support the county Ag Ambassador program, which incorporates several of the Ag in the Classroom resources from the WFBF. We donated \$1,000 for the county fair premiums for youth exhibitors.

Our Young Farmer and Agriculturist (YFA) program continues to grow. Chris Pollack stepped down as the county YFA chair and is serving as a board of director for the Town of Metomen. Mike Leahy and Liz Koeck are the new co-chairs of the committee.

The committee continues to have a successful pizza-making

fundraiser each year and conducts a variety of other programs throughout the year.

The county also continues to be involved in the legislative process. Several members attended the Ag Day at the Capitol in Madison last January.




- 1. We support a collaborate effort with industry partners in development of best farming practices.
