The Ronald McDonald House has been renovated and is a beautiful place to visit.



Ag Day at the Capitol is an annual event sponsored in part by the Wisconsin Farm Bureau Federation.

St. Bernard's Catholic School Students Top County Agriculture Essay Contest



Jefferson County Ag in the Classroom essay coordinator Patti Hurtgen presented Nolan Schopp his certificate. The Ag in the Classroom program sponsors an essay contest each year for fourth and fifth grade students in Wisconsin. Jefferson County selects the top three essays and submits the winning entry to the district competition, where the district winner then advances to the state level. The 2015 topic was "Why are bees important to Wisconsin agriculture."

Jefferson County had 162 essays submitted, the most in District

1's eight-counties. This year the winning essay was from fourth grader Nolan Schopp of St. Bernard's Catholic School in Watertown. This is his winning essay:

Why are bees important to Wisconsin Agriculture?

Did you know that one-third of the human diet is derived from pollinated plants? Bees are responsible for 80 percent of the plant population. Here in Wisconsin, bees play an important role. Bees pollinate crops like apples, cranberries and cherries. Bees also help people with gardens in their backyard by pollinating plants like beans, cucumbers, tomatoes and pumpkins. In their spare time, bees also make sweet delicious honey.

Bees are good pollinators for several reasons. They have hairy bodies that trap pollen and carry it from flower to flower. They need larger quantities of nectar and pollen to take care of their young so they visit flowers often to obtain food. If bees did not pollinate these flowers there would be a larger loss of crops. For example, Wisconsin apple growers would lose as much as 80 percent of their crop if there were not any bees.

In my garden, I would not have the healthy food choices that I do if it weren't for bees. I like eating watermelon, peas, carrots, beans and cucumbers from my garden. I also grow pumpkins for Halloween. Bees make honey because it is high in energy and helps them put

nutrients back in their bodies. They need energy to fly many places. Bees collect nectar and store it in their hive. The nectar concentrates into honey. Bees fly about 55,000 miles to make one pound of honey.

Bees are very important. They provide many people with food. The next time you see a bee, don't squish him. Thank him for pollinating all of the plants that provide good, healthy food.

On April 22, Patti Hurtgen, Jefferson County Ag in the Class-room essay coordinator thanked the students at St. Bernard's Catholic School in Watertown for submitting essays. Nolan Schopp read his essay to the class and was presented with his certificate and check. She also has a surprise for Nolan and his classmates. For writing the county's winning essay, Nolan received an ice cream sundae party for his entire class.

The students enjoyed ice cream sundaes with a variety of toppings in celebration along with Nolan's teacher, Mrs. Debra Ruddell. Her students had a presentation earlier this spring about bees and the new technology instructor worked with students to download the resources available from the Ag in the Classroom brochure.

Ag in the Classroom volunteer, Daphne Holterman presented Asha with her certificate and check on April 29. Holterman was a guest speaker for Mrs. Anderson's class and she spoke on the various ways farmers recycle and

reuse products to keep agriculture sustainable.

The third place essay winner was Sara Neary, who is a student in Ms. Victoria Toebe's fifth grade class at Johnson Creek Elementary School. She also received a certificate and cash prize.

All teachers in the county whose classes submitted essays received \$30 gift cards to Nasco, which was provided by the Jefferson County Farm Bureau. Participating schools include Cambridge Elementary School; Johnson Creek Elementary; Ixonia Elementary School; St. Bernard's Catholic School in Watertown; St. Henry's School in Watertown, St. Paul's Lutheran Grade School in Fort Atkinson and St. Peter's Lutheran School in Helenville.

The Wisconsin Ag in the Classroom program is coordinated by the Wisconsin Farm Bureau. It provides many opportunities to educate youth about agriculture. Locally, fourth grade classes get to visit farms throughout the spring, second grade students in the county are treated to "A Day without Agriculture" presentation by Ag in the Classroom volunteers.
