

Policy Approved at Annual Meeting

Kenosha County Farm Bureau voting members were presented each of the following policies at the annual meeting. Each of these policy measures will be passed on to the national, state or local level for consideration.

LOCAL

1. Whereas current statue states a governmental body shall post public notice of a meeting or hearing in a newspaper and post a copy of such notice in a town or village hall. And whereas many landowners are not notified when issues are publicly discussed concerning their property.

Be it therefore resolved that when governmental bodies are deciding zoning, changes in zoning, special assessments or other actions affecting the value of private property, that the landowners of this property and adjoining neighbors, be notified in writing prior to the scheduled date of these meetings or hearings.

2. We support a shared UW Extension Agricultural Agent between Kenosha and Racine Counties. That individual would have attributes that will be well used in the surrounding counties as well.

STATE

1. Whereas the State legislature has addressed the issues of property tax reform on Farmland and its assessed value mechanism.

Be it therefore resolved that Wisconsin Farm Bureau Federation stay watchful on these issues ensuring that significant alterations from the original intent do not occur.

- 2. Be it resolved that WFBF support the education of our young drivers as to the recognition of and reaction to agricultural signage for the safety of all drivers, whether that class is sponsored by a school, state program or private driving school. And be it resolved that all driver's education programs be monitored by the Department of Transportation, and kept to the same standards.
- 3. We support state legislation to ban the use of cell phones while driving, unless using a hands-free device.
- 4. We support a nutrient management planning that has a two tiered plan for smaller and larger acres to be compliant with the farmland preservation program.

- 5. We propose that when engineering a road the state and local level of governments should install culverts to assist in transporting manure to reduce traffic on roads.
- 6. We support the ability for immigrant workers to obtain a valid drivers license providing they meet the criteria of the current state driving requirements.

NATIONAL

1. Whereas there is a continuing tendency to overspend in the national budget, thereby increasing the nation debt.

Be it resolved that Farm Bureau continue our support for a balanced budget.

2. Whereas Ag. Trade is an important part of U.S. trade internationally and currently the U.S. has a large foreign trade deficit.

Be it resolved that AFBF continue the drive to reduce this deficit by marketing more of our agricultural products abroad, support U.S. trade delegations and support free trade of America's wherever possible, however recognizing some products are more sensitive than others.

Kenosha County Agriculture - A Snapshot



Kenosha County is a diverse county featuring a variety of livestock enterprises including horses, dairy, beef, swine and nore. The nursery and greenhouse industry is very important to the county, meeting the needs of the urban and rural areas with bedding plants, flowers, trees, sod etc. Grains take up the majority of the acreages in the county. The look of agriculture continues to change as the county is home to many small scale farming operations which includes poultry, sheep, goats, vegetables and much more. Pop Tabs Wanted




HOUSE CHARITIES

Keep saving your pop tabs for the Ronald McDonald House! Ronald McDonald House is a "home away from home" for families of seriously ill or injured children. Since their doors opened in 1984, more than 35,000 families have stayed at the Ronald McDonald House in Milwaukee while their child received critical medical care. In 2013 alone, they served nearly 1,000 families. They have been at full occupancy with their 38 guest rooms-often with a wait list of anywhere from five to 20 families each day.

At the district 1 Ronald McDonald House event on May 3, 78.85 pounds of pop tabs were collected. Each district is having a competition that goes through December, so keep saving your pop tabs.

Since 2000, little aluminum tabs on the tops of soda cans have meant more than \$210,000 to the Ronald McDonald House. Revenue from recycling these little bits of aluminum helps provide a home away from home



for families whose seriously ill children are undergoing treatment in the Milwaukee area.
