Marathon County Farm Bureau Annual Meeting Wrap Up



Marathon County Young Farmer and Agriculturists hosted an On-The-Farm Town Hall on October 23 at Misty Hollow Farms in Athens.

It started with a wonderful farm tour, led by owners Eric and Misty Vogel. They answered questions about daily struggles and triumphs in dairy farming, as well as what drove them to use the Lely robotic milking system.

We then moved to the forum portion of the event and we were joined by candidates Katrina Shankland, representing Russ Feingold for U.S. Senate; Tom Tiffany - District 12 (for farm tour); Pat Snyder - District 85; John Spiros - District 86; Michael Tauschek - District 86; James Edming - District 87;

and Elizabeth Riley - District 87. Candidates answered questions with topics including: right to farm bill, farm size and pollutions, management practices and future budget goals.

Attendees socialized with the candidates following the forum as well, asking them specific questions that were of concern. It was interesting to visit and learn with each candidate, as some had experience in farming and small business, while for others this was a first time visit to a farm.

Grassroots Policy: Marathon County Farm Bureau Approves Resolutions



The Marathon County Board of Directors presented resolutions at the Marathon County Farm Bureau annual meeting on October 6. All resolutions passed and will make their way to the Policy Development Committee, which is made up of volunteers from around the state. Last year the committee reviewed about 500 resolutions.

If you have questions or concerns or maybe you believe that there is another issue that needs to be dealt with. Make sure that your voice is heard by contacting a county board member.

State

- 1. We are in favor of appropriate, uniform and consistent regulation and increased fines across the state for farms that intentionally, willfully or neglectfully allow manure to enter waterways or wetlands and do not follow nutrient management plans. Natural Resources and the Environment: Nutrient Management Regulations
- 2. We support managed grazing as an approved method of stream bank and wetland management. *Natural Resources and the Environment: End*
- 3. We are in favor of mandatory drug testing for any and all recipients of state aid. *General Government: Nutrition Assistance*
- 4. We support minimum state conservation standards without cost sharing with the exemption of capital improvements such as manure pits. *Natural Resources and the Environment: Non Point*
- 5. We support ending the Stewardship Program as the state does not have funds to purchase additional land. *Land Use: Stewardship Program*
- 6. Gas fuel taxation. Fuel Tax
- 7. We support the use of real Wisconsin products in all publicly funded education classes. *Education: Elementary and Secondary*
- 8. We no longer believe that the Wisconsin Milk Marketing Board should provide financial incentives for the placement of vending machines in schools due to Smart Snack Restrictions. *Dairy: Promotions*
- 9. We support DATCP to be required to repeal atrazine prohibition if three consecutive groundwater samples taken at intervals of at least six months show that the concentration of atrazine and its metabolites are below 50 percent of the enforcement standards. If there are other wells in the area, they are to be tested to verify that the concentration of atrazine and its metabolites also do not exceed 50 percent of the enforcement standard. *Natural Resources and the Environment: Ag Chemicals*

- 10. We are in favor of rural areas receiving the same governmental aide that urban areas have received to gain access to broadband internet. *Energy: Telecommunications*
- 11. We support amending the current fence law. Livestock owners should be required to build and maintain fences to contain their animals. *General Government: Fences*
- 12. We are in support of harvesting wetland vegetation for agricultural use. *Natural Resources and the Environment:* Wetlands
- 13. We support all school busses flashing both amber and red lights 200 feet prior to a stop. *Transportation: Safety*
- 14. We support requiring all animal drawn vehicles to have a slow moving vehicle sign, effective lighting, and reflective tape on public roads. *Transportation: Safety*
- 15. We support farmers and trained employees to administrate all animal health husbandry practices. *Livestock: Animal Welfare*

Federa

- 1. We support eliminating the Conservation Security Program (CSP).
- We support the addition of nutrition requirements to SNAP dollars to be consistent with the Healthy Hunger Free Kids Act.
- 3. We are in favor of utilizing horse meat for human consumption as well as pet food and other uses.
- 4. We support the removal of wolves from the endangered species list.
- 5. We support farmers and trained employees to administrate all animal health husbandry practices.
- 6. We are in support of management practices to aid in keeping cows cleaner and improving the overall farm image and safety of those working directly with the cattle.
- 7. We oppose the EPA proposal to ban atrazine.
- 8. The FCC needs to hold companies accountable that receive federal funding for rural broadband.
- 9. We support a national security policy that prioritizes protection from cyber terrorism. Sec. 179 p. 47 (2.3). This would be an addition to AFBF's National Security Policy priorities.
- 10. We are in support reforming the Dairy Margin Protection Program.

Internal Resolution

- We support the UW Collegiate Farm Bureau membership, also include two-year technical and community college campuses
- We are in support of current state YFA committee members being eligible to compete in state contests while they are serving on the state YFA committee.
- We encourage Wisconsin Farm Bureau to work jointly with commodity organizations for lobbying efforts to represent agriculture.

Essay Contest Deadline is April 1

Wisconsin fourth and fifth grade students are encouraged to participate in the Ag in Classroom essay contest answering the statement, 'Tell us about cranberry production in Wisconsin during one of the four seasons.'

Essay submissions must be 100- to 300-words in length and will be judged on content, grammar, spelling and neatness. Contest rules, lesson plans and sample classroom activities are at wisagclassroom.org. Participating students and schools need to submit essays by **April 1.**

The essay contest coincides with the Ag in the Classroom 2017 Book of the Year, *Time for Cranberries* by Wisconsin author Lisl H. Detlefsen. The book and essay topic allows students to learn about cranberries and the important role they play in agriculture. Last year, more than 3,000 students participated in the contest, which is sponsored by Insight FS, We Energies and the Wisconsin Farm Bureau Foundation.

Ag in the Classroom is designed to help students in understand the importance of agriculture. It is coordinated by the WFBF in cooperation with the U.S. Department of Agriculture and with a grant from DATCP.
