Three members were recognized for their 25th consecutive year of membership. They were Harold Ellenbecker, Mike Birling and Robert Weiland.

The members present elected members to the board of directors, elected delegates to represent OCFB at the WFBF Annual Meeting in December and approved resolutions to propose to Wisconsin Farm Bureau policy.

Kevin Burmeister was elected to finish the second year of a two-year term representing board district 1.

Elected as Women's Committee chair was Katelin Haglund.

WFBF Annual Meeting delegates elected were: Mike Salter, Michelle Backhaus, Katelin Haglund and Bernie Vander Heiden. LeRoy Van Asten, Dan Knutzen and Dave Daniels will standby as alternates.

The resolutions that passed were:

1. Counties should work together to share UW-Extension agents.
2. If special interest or government initiates legislation which leads to regulation that impacts the economy, the natural or the human environment, or right to property or its use, they shall collectively provide reimbursement for that impact.
3. We support increasing road weight limits on the interstate system to 97,000 pounds for trucks with six axles.

Reports were presented by the OCFB committee chairs about the many promotional, educational and social events that took place this past year. Chuck Reitz III, Rural Mutual Insurance Agency Manager, told about Rural's strong relationship with Farm Bureau and solid position in the market place.

Guest speaker, 12th District Senator Tom Tiffany, discussed his experiences in the state legislature and many issues facing agriculture.

President's Report



This has been an interesting year. There have been many priority changes in Farm Bureau. One year ago our main goal was to get a farm bill. Now they are trying to install all the parts of it. This year we are trying to decide what political candidate we want to represent us and we also have to make a choice on our governor.

In this past year Outagamie County Farm Bureau had another graduate of the Farm Bureau Leadership Institute class, Michelle Backhaus. Now our county has three graduates and

we are always looking for more candidates. You do not have to be a board member to apply. The Institute program consists of five sessions, four of them are here in Wisconsin, with one being a two-day session in another state's Farm Bureau office to learn how other states operate. The final session is a trip to Washington, D.C. to see first-hand how our country's political system works.

Our county Farm Bureau also had one member (Bernie Vander Heiden) selected from our district to go out to Washington, D.C. and explain to our representatives and senators points of interest to farmers. A very important part of Farm Bureau is legislative action. Whether it's local, state or

national, we have to inform our representatives of our needs. One of the things Farm Bureau worked on this past year was Implements of Husbandry legislation. We now have a bill that improves the situation for farm equipment, but as many of you know it is not perfect and will continue to be changed as needed.

I heard that Outagamie County Farm Bureau had a great annual meeting. I am sorry I couldn't be here for it as I was in Washington, D.C. talking to our legislators about the trade bills and why they are needed for farming to prosper.

District 7 Policy Development Meeting

The District 7 Policy Development meeting was held August 11 at Anello's Torchlight Restaurant in Shawano. Twenty eight members were in attendance from six counties. Wayne Staidl, District 7 Board Representative, conducted the session and Paul Zimmerman, WFBF Executive Director of Governmental Relations, was there to provide background information and assistance during discussion. The group discussed issues and ideas that they could possibly take back to their county Policy Development meetings.

Attending from Outagamie County were Aaron Burmeister, Dave Daniels, Marvin Fox, Mike Salter, LeRoy Van Asten and Bernie Vander Heiden.

Issues and ideas discussed were:

- Municipalities might want to insure wind generators in their jurisdiction.
- Large farm size can be a barrier to entry into farming.
- Autism in the population is increasing – is it related to GMO foods?
- If bats are placed on the Endangered Species List it could create problems for the forestry and crop farming industries.
- Algae/water quality problems – what can agriculture do about the problem to help?
- Today's young people have too many hurdles that tend to discourage them from choosing a farming career.
- OSHA law is outdated – exemptions should be updated.
- School district budgeting – conservative spending districts shouldn't be penalized.
- State School Aids should give an incentive for frugal budgeting.
- Farm data security needs to be addressed in WFBF policy.
- Driver's licenses for immigrant labor – Should background checks be necessary? What other requirements should they have?
- Should high capacity wells be more highly regulated to allocate water resources in Wisconsin?
- Could UW-Extension funding be separated from Public Radio to allow more favorable funding of Extension agents salaries?
- Combining UW-Extension services across county lines is a good thing.
- Child labor laws – Young people as young as 10 years old should be able to legally work in agriculture.
- Trucks should have higher weight limits on the Interstate highway system.
- Hemp should be legal to grow as an ag crop.

District 7 YFA Discussion Meet

Four contestants competed: Brian Preder (Waupaca County), Heidi Pettis (Shawano County), Andrea Korth (Outagamie County) and Patty Sellen (Oconto County). 
