



District Director Report



I recently had the opportunity to travel to Washington, D.C. with the Farm Bureau Institute class. Two things continue to impress me. One is the respect that Wisconsin Farm Bureau gets from our representatives and the other is the leadership Farm Bureau continues to grow. We continue to grow leaders not only for our organization but for our communities. Everyone who has gone

through the Farm Bureau Institute class has been challenged and has become a stronger leader and communicator. It is also extremely important for all farmers to communicate with our representatives this year.

Recently, the EPA made a ruling redefining "waters of the U.S." under the Clean Water Act. This ruling has grossly overreached the regulator authority of the EPA to many ditches and farmland. Although the EPA has offered an exemption for agriculture, I believe the EPA doesn't have the authority to offer such an exemption. If we accept this authority at this point, we also would have to except it if the EPA removed the exemption. Please contact your representative and senators to tell them how such an overreach would affect you on your farm. Representative Petri recently announced his retirement. I want to express my gratitude to him for his years of service to his district and to this country. I encourage everyone to have discussions with the candidates and vet how they will protect our rights as land owners.

I also want to personally thank everyone who has been involved in the strategic planning process. It is an important part of developing and prioritizing the future of our organization. A major part of the future and a way to also save Farm Bureau money is by using more electronic communications. In order to do this we must have your email addresses. Nearly 400 members of various farm and commodity groups attended Ag Day at the Capitol on Wednesday, January 29 at the Monona Terrace Convention Center in downtown Madison. It was there they heard from Governor Scott Walker about the importance of agriculture to Wisconsin. Members also heard from WFBF Government Relations staff Paul Zimmerman and Karen Gefvert who briefed everyone about issues including implements of husbandry, animal welfare, raw milk and more. WFBF Women's Committee Collect Pop Tabs for Ronald McDonald House

In 2013 the WFBF Women's Committee and volunteers from their districts came together to help in a one day project at the Ronald McDonald Houses in Madison, Milwaukee and Marshfield. The committee and volunteers cooked and served meals, provided games and crafts for the children and donated food, books, toys,



clothing and monetary donations. This year the committee will once again conduct this project in all three houses in addition to a Pop Tab Challenge.

What is a pop tab? Pop tabs are the little aluminum tabs from all kinds of cans: soda, some pet food, canned fruits, vegetables and more.

How do pop tabs help the Ronald McDonald House? Once the pop tabs are collected and turned into a Ronald McDonald House, they are taken to be recycled in exchange for dollars, which support the children and families staying at the Ronald McDonald Houses.

The pop tab challenge is a statewide project which began in January and will run through November with the final collection of tabs from each district being dropped at the WFBF Annual Meeting trade show at the Kalahari Resort in Wisconsin Dells this December 6-8. The women's booth at the trade show will have nine tubs labeled District 1-9. Attendees are asked to drop their collection in their district's tub. You may also drop off pop tabs at the Winnebago County Fair food stand or the county annual meeting.

Discussion Meet Questions

- 1. How would the condition of government-managed public lands change if they were managed privately? What are the pros and cons of government ownership of land versus private ownership?
- 2. Should farmers and ranchers be held liable for possible food-borne illnesses when the food item of concern can be traced back to their farms or ranches? Why or why not?
- 3. The farm bill crop insurance provisions offer a safety net for crop loss

due to natural disaster and/or price risk. Should a safety net for livestock producers be developed, and what provisions might it include?

- 4. How can young farmers and ranchers work to encourage membership growth and member engagement for the county, state and national Farm Bureau organizations?
- 5. How should our nation's policies balance concerns about food insecurity against concerns about the safety or environmental impact of modern agricultural technologies? What role should farmers have in discussing and debating these issues in our society and with our lawmakers?

Question #4 will be used for the district Discussion Meet.

Winnebago County Farm Bureau Offers Scholarships

The Winnebago County Farm Bureau is pleased to announce that it will award two \$500 higher education scholarships. The scholarships will be awarded to two students (including graduating high school seniors) who are enrolled in an accredited college,

university, technical college or FISC. All majors will be considered for this scholarship; however, priority is given to students enrolled in an agricultural field of study. Applicants will be judged on leadership, scholastic achievement (minimum GPA of 2.5 on a 4.0 scale), extracurricular activities and future goals. Applicants must be from a current Winnebago County Farm Bureau member family. Applicants not receiving scholarships may reapply in subsequent years, but recipients of one of these scholarships will not be eligible to apply again. An outside selection committee, chosen by the Winnebago County Farm Bureau board of directors, will determine scholarship recipients. Winners will be announced at the Winnebago County Farm Bureau annual meeting. Awards will be mailed directly to the trust department of the recipient's school by October 15.
