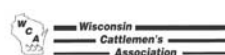

OCONTO COUNTY FARM BUREAU EDITION

Estate Planning and Farm Succession Workshop

Oconto County and Marinette County Farm Bureaus partnered together to provide an estate and succession planning workshop for members interested in learning solutions to issues when passing on the family farm assets to the next generation.

Passing on a business to heirs can become complicated when parents want to be “fair” to all of their children, especially when one child, or even all, are not actively involved in the family business of farming.

About 40 people attended the seminar held January 14 at Romy’s Holiday Inn at Kelly Lake, which included a complementary lunch of chicken and tips courtesy of the Oconto and Marinette County area Rural Mutual Insurance agents.

Richard Bollenbeck, Attorney at Law from Appleton, spoke on how estate planning can help set up revocable trusts that protect investments from higher Wisconsin state death taxes or federal estate taxes. Revocable trusts help avoid the Wisconsin probate system which often delays passing on an inheritance for almost 12 months and the fees that go along with it. The revocable trust owner can maintain control of their assets up to the time of death and can be amended or changed at any time.

Senior Regional Financial Consultant Jared Nelson offered insight on building a long-term financial plan that addresses possibilities of long-term care, life insurance policies and long-range budgeting. He also explained differences in “whole” versus “universal” life insurance plans, which offer different investment, or non-investment, options.



Jared Nelson, Senior Regional Financial Consultant with Farm Bureau Life Insurance, helped attendees understand the many options that are available to make successful business transitions for farm families.

Dr. Sarah Mills-Lloyd, Oconto County Agricultural agent, gave a presentation on farm succession planning and its importance in order to ensure maintaining a thriving farming business. She addressed the necessity of incoming generations needing adequate management education to boost long-term profitability.

“Situations where aging farm owners remain dependent on business assets for long-term care or for covering unplanned and unexpected expenses need to be carefully addressed to promote open communication for sharing of information regarding protecting farm assets,” Mills-Lloyd said.

Family members engaging in discussion regarding present and future decisions about the family farm can sometimes initiate conflict, which can be resolved when an estate plan is developed and in place.

Bollenbeck and Nelson offered free consultations to workshop attendees interested in more information specific to their individual situations at the Farm Bureau office in Oconto Falls.

Mills-Lloyd is partnering with Marinette County Agricultural agent Scott Reuss, Attorney George Twohig from the law firm of Twohig, Rietbrock, Schneider & Halbach S.C. of Chilton and Greg Anderson, Certified Public Accountant from the Manitowoc accounting firm of Ihlenfeld, Skatrud, and Anderson to offer a second, more in-depth look at farm succession planning.

“It’s a strong need in our counties,” Mills-Lloyd said. “We wanted to continue conversation about the issue in a different setting.”

trict. She developed a very active Ag in the Classroom program in the county, providing educational materials to the schools and libraries and a display and activities at the Oconto Falls Fair.

She also was in charge of the Ag and Me essay contest for fourth and fifth graders. She also convinced several YFA members to participate in the WFBF YFA Discussion Meet contest where they did very well.

Vicky will be remembered for her upbeat attitude and her refusal to let her illness slow her down. She revived the orange juice sales and organized a gardening class and plant sale with the Oconto Falls Vo-Ag Department.

At the OCFB Fair booth it seemed she knew everyone and always had time to visit. She will be missed on the board for her vibrant attitude and her ability to expect and bring out the best in the people around her.

The Rural Mutual Insurance report also showed an increase. Rural insures 35 percent of farmers in the state and has 275 agents.

It's always a joy to meet old friends and make new acquaintances at our annual Farm Bureau meeting.

In Memory of Dolores Schroeder

For approximately 15 years she ran the June Dairy Month recipe contest. Women from all across the county submitted dishes, ranging from desserts to casseroles, based on dairy products that were then submitted to a taste test. Dolores put these recipes in a cookbook that the Oconto County Farm Bureau sold as a fundraiser.

She also served on the state Farm Bureau Dairy Committee and was the first woman to serve on that committee.

Dolores will be remembered for her community activities and her dedication to Farm Bureau and the ag community as a whole.

There may be a little truth in that, but Farm Bureau provides the means through which farmers and agriculturists can find the common ground they need (no pun intended) to be able to make things better for their farms and agri-businesses in the nation, this state, this county and their local area.

At the 95th WFBF Annual Meeting, Chad Hymas was the keynote speaker. He was severely injured at age 27 when a big square bale of hay fell on him and broke his neck. His address was entitled, "Who needs legs, when you have wings." Those of

you reading this probably have the use of your arms and legs, and by becoming actively involved in Farm Bureau you also can take wing.

The Oconto County Farm Bureau has four vacancies on the board of directors. This is a great opportunity for a person from the District 1 area north of Highway 22, a person from the District 2 area south of Highway 22, a woman to serve as a board member as chair of the OCFB Women's Committee and a person age 18-35 to serve as a board member and as chair of the Young Farmer and Agriculturist (YFA) Committee.

Board members are paid a per diem of \$10 per meeting attended and are reimbursed for their mileage to board meetings at the rate of \$0.30 per mile. Chairs of the Women's and YFA Committees receive an additional \$200 annual per diem if they attend or send a written report to at least 50 percent of the board meetings. Board meetings are held on the fourth Tuesday of each month (except May and December) at the Oconto Falls Rural Insurance office.

2014 Orange Juice Sale Update

Thank you for all who ordered orange juice this year! In past years, the Oconto County Farm Bureau planned their annual orange juice fundraising event to coincide with the Oconto Falls FFA annual fruit sale. By combining the sale events and using the Florida Farm Bureau as the distributor, the orders from both organizations shipped together, saving on costs.



This year, the Oconto Falls FFA opted to use a different supplier for the fruit sale, requiring the Oconto County Farm Bureau to seek other shipping options. In essence, the Oconto County Farm Bureau needed to work with another county Farm Bureau organization in order to have orange juice shipped to our area.

Vicky Harter, an Oconto County Farm Bureau board member until last November, found a way to do this by engaging assistance through the Outagamie County Farm Bureau so that our county was able to continue offering orange juice as a purchase item.

Sales increased slightly from last year. Because of the adjustment made in shipping arrangements, the Farm Bureau had less time to take orders. As a result, all sales were made by phone or by word of mouth in less than two weeks.

The Outagamie County Farm Bureau provided a delivery point and the pickup for Oconto County's order was accomplished by our wonderful volunteers.

Thank you to all who helped make the orange juice fundraiser continue to be a success for Oconto County Farm Bureau!
