### Olsons Recognized as Buffalo County Farm Family of the Year

Doug and Karon Olson were honored as the Buffalo County Farm Bureau Farm Family of the Year at the Buffalo County Farm Bureau annual meeting on October 12.

Doug and Karon Olson of Mondovi, farm 2,000 acres of corn and soybeans and own and operate a custom planting and harvesting business known as Olson's Farm Service. They also have a partnership farm with Doug's brothers, Bruce and David.

Doug started his love of farming as a child working for his father at Huntsinger Farms and working the horseradish fields. As he grew older, he began milking cows on weekends for a neighbor. After graduation from high school, he attended Chippewa Valley Technical College in Eau Claire for diesel mechanics. After completing school, he started working at the John Deere dealership in Mondovi.

Karon started her love of farming as a child growing up on a dairy farm in Gilman Valley where she helped her parents.

Doug purchased his first combine in 1977. He purchased a second combine in 1978. They continued adding to the business with his father Darrel and brother Bruce helping him. Doug and Karon were married on August 30, 1980. They began their partnership farm with Doug's father and his two brothers. With the partnership, they raised produce and had a roadside stand until 2012 and still operate three greenhouses outside the city limits in Mondovi where they grow and sell annual and perennial flowers, hanging baskets and vegetable plants.

Doug and Karon have three daughters, Amanda, Bridgette and Christina. Christina works on the farm daily with Doug and Karon. They have one grandchild.

They have a wet bin and dryer that became a grain handling facility: Harvey Creek Grain LLC. At the same location in 1996, they built a liquid fertilizer facility.

Doug and Karon are active in the community. Doug helps with Mondovi Friendship Days and the Buffalo Country Fair tractor pulls. Karon works with the Mondovi Area Food Pantry and serves on the Central Lutheran Church finance board. They both work at the Farm Bureau malt stand. Last year, Doug has made modifications at the malt stand that have greatly improved the efficiency of the stand.

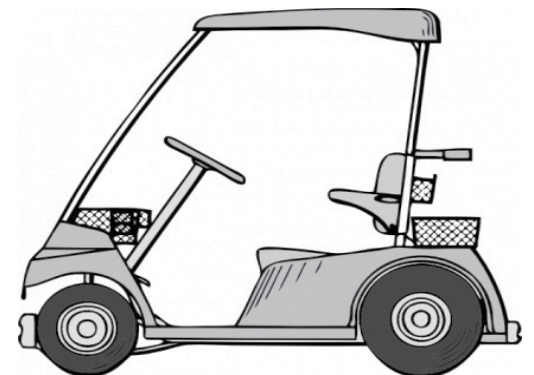
### Plan to Participate in the Wisconsin Ag Open

## Buffalo County Farm Bureau Members Participate in Policy Development

Delegates of the 2017 WFBF Annual Meeting gathered at the Kalahari Resorts in Wisconsin Dells on December 4 to set WFBF's policies for the next year.

Buffalo County Farm Bureau continues to work for farm families and individuals who are involved in or support agriculture.

Recently, four members of the Buffalo County Farm Bureau board attended the WFBF Annual Meeting as voting delegates for the policy discussion; one of the items on the agenda at the business meeting.

Input from local Farm Bureaus on issues and concerns in the farming community, follow a policy development process. Policy input at the local level may even be supported enough to be voted on at the WFBF Annual Meeting.

The resolutions and policies that were passed at the annual meeting are divided into the following categories: dairy, education, energy, farm finance, general government, health and safety, labor, land use, livestock, marketing, natural resources and environment, taxation and transportation.

Policy developed by Farm Bureau throughout the state are not just on farm issues, if you were to take time to review the resolutions and policies acted on at the recent annual meeting you may be surprised.

Following is an example of a couple resolutions that were passed at the annual Farm Bureau meeting that will affect a group of individuals that are not farmers and currently, probably not Farm Bureau members, such as, "support maintaining state funding to school districts with declining enrollment with special consideration for rural schools," and relating to telecommunications, "support expanded for cellular and broadband telecommunication coverage for rural areas."

I had the opportunity to attend the WFBF Annual Meeting. This was not my first opportunity at the WFBF Annual Meeting, but after this meeting, I came away with a different sense of Farm Bureau and membership. While we encourage farmers in our county to be members of Farm Bureau, I learned there is another group of individuals who may benefit by supporting the initiatives of Farm Bureau and becoming a member based on a wide range of issues that are supported by Farm Bureau at the county and state level.

## Ag in the Classroom Announces Essay Contest

Each year, the Ag in the Classroom program holds an essay contest in conjunction with the book of the year for fourth and fifth grade students throughout the state. This year's essay contest topic is: 'Inventions that have made agriculture great.'

"Technology is something that many students don't associate with agriculture," said Darlene Arneson, Ag in the Classroom Coordinator. "This year's book and essay contest will give students the opportunity to explore how technology is helping produce food, fuel and fiber and for teachers to incorporate ag into their STEM curriculum."

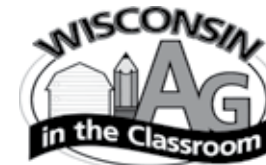
Essay submissions must be 100- to 300-words in length and will be judged on content, grammar, spelling and neatness.

Nine district winners will be selected with one being chosen as the state winner in May by the WFBF Promotion and Education Committee. Each district winner will receive a classroom presentation for their class.

## We're Going all the Way: A Message From the District 4 Director



I have never been prouder to be a part of Farm Bureau than after going to this year's AFBF Annual Convention and seeing the impact our state has.

Wisconsin is quite small with more than 40,000 members when you compare us to Tennessee's 600,000 plus members. Imagine our three delegates up against theirs during the

policy development process.

Before I dive into AFBF, I want to start from the beginning with a local resolution going all the way to the top and building national consensus.

A resolution that was brought forth by a Buffalo County Farm Bureau member was adopted by the membership of Buffalo County Farm Bureau during the county annual meeting in 2016. The resolution: We support industrial hemp production.

This was not the first time it was proposed, but confusion between industrial hemp and its very close cousin, marijuana, prevented the adoption of the resolution in 2015. After gathering more information and presenting at the District 4 Policy Development meeting, several other counties in District 4 also considered forwarding a resolution in favor of industrial hemp production in Wisconsin and the USA.

The following resolution was adopted: We support the production, processing, commercialization and utilization of industrial hemp and that it be regulated by the USDA rather than the Drug Enforcement Administration (DEA).

Great, we have a resolution; does it stop there? Absolutely not! Following the 2016 WFBF Annual Meeting, the task of promoting our policies went to our outstanding Governmental Relations team including: Paul Zimmerman, Karen Gefvert, Rob Richard and Steve Boe.

Rob Richard became the lead person studying and promoting industrial hemp legislation. Our resolutions process is closely

followed by many of our legislators and after our approval of industrial hemp, Representative Jesse Kramer (R-Kewaskum) approached Rob Richard with his bill supporting industrial hemp and, we were off to the races. Following a process of educating people on the differences between industrial hemp and marijuana, the once huge industrial hemp processing capacity that existed not only in the USA but with Wisconsin being one of the largest producers and the current \$600 million of hemp products being imported in the USA. We were in a position to have a hearing on the bill, so close.

With a lot of support and advocacy from Farm Bureau members, especially in Monroe County, we moved the bill forward and guaranteed its success. The members came through!

Countless phone calls and contacts were made from our members especially in Monroe County, county agents expressed interest in researching new opportunities that industrial hemp could provide for farmers, as well as our governmental relations team making contacts at high levels.

The Industrial Hemp Bill got a hearing without opposition. The bill passed the Assembly and the Senate without opposition and was signed into law as ACT 100 by Governor Scott Walker on November 30, 2017. That's right, Google it: Wisconsin ACT 100, 2017.

The Wisconsin Department of Agriculture, Trade and Consumer Protection has 90 days from November 30, to set up the rules by which farmers can grow industrial hemp. We will have seeds in the ground in 2018!

Back to AFBF Annual Convention, where I started. While Wisconsin may have a small number of delegates, we accomplished much by our ability to build partnerships with other states.

The Wisconsin delegation organized and held two meetings on industrial hemp and dairy policy with other interested states. On the issue of industrial hemp, Congressman James Comer (R-Kentucky) discussed the strong interest in industrial hemp legislation from a bi-partisan perspective and what was needed for national legislation to happen.

Rob Richard secured the written support of 27 state Farm Bureau presidents. AFBF delegates passed a resolution in support of industrial hemp and now we will complete the process

of pursuing legislation at a federal level so that we can move this process to home base.

I am very pleased to announce that in our District, Congressman Ron Kind (D-Wisconsin), signed onto the bill Congressman Comer authored. Five of Wisconsin's eight congressional delegates have signed onto Congressman Comer's bill, tied with Colorado for most co-sponsors from any state.

Whether it is industrial hemp, dairy policy or several others including the allowing of milk to be labeled by its fat free content (99% fat free versus 1% fat), Wisconsin Farm Bureau has worked to build strong credibility with other states. Even if we are relatively small in relation to other state Farm Bureaus, we carry a lot of weight for our members.

So, remember to share your issues or ideas ... we really can make things happen!
