All proceeds raised from the breakfast will directly benefit the county's scholarship program.



## Institute Graduates Talk Ag on Capitol Hill

Farm Bureau leaders became lobbyists for a day while meeting with Wisconsin's congressional delegation in Washington, D.C., on April 13-14.

The topics discussed were trade, immigration, wolves, food labeling and the farm economy. Graduates of the Wisconsin Farm Bureau Foundation's Institute leadership course were joined on Capitol Hill by the Wisconsin Farm Bureau's Board of Directors.

The trip marked the completion of the Institute, a year-long leadership training program available to Farm Bureau members.

"Being aware of political changes and how they can or will affect my farm and life are important to me. The Institute has helped me to think outside of the box when talking with my representatives. I was able to share with them exactly

While in Washington, Farm Bureau members met officials from the American Farm Bureau Federation and the U.S. Department of Agriculture where they discussed issues pertaining to wetland conservation, telecommunication and broadband expansion, food safety and national preparedness for animal disease. A visit to the New Zealand Embassy included a conversation on trade and the global agricultural economy.

In addition to meeting with Senators Ron Johnson and Tammy Baldwin and their representatives in the U.S. House of Representatives, Farm Bureau members also toured the floor of the U.S. House of Representatives' chambers.

## Watch for Ag Transportation Tidbits

Now that the implements of husbandry (IOH) trilogy is complete, but so many questions still remain, there has been discussion of creating a Wisconsin agriculture transportation guide book.

This book will encompass aspects of operating or transporting ag-related equipment and supplies within Wisconsin highlighting both state and federal laws.

Wisconsin Farm Bureau Senior Director of Governmental Relations Rob Richard and Cheryl Skjolaas from the UW-Extension are working with the Wisconsin Department of Transportation to write this guide book with a goal of completing it by September 1.

In preparation for the guide book, WFBF is rolling out 'Today's Ag Transportation Tidbit' on social media. These posts are simple, yet important, transportation laws or rules that apply to ag-related equipment and its operation or transport on Wisconsin roads.

Even though you may know these laws, it's our hope that you share them via social media to reach and educate a much wider audience. More importantly, any feedback that you provide will help us prioritize specific issues for the guide book. For example, did you know that it is not legal to pass an implement of husbandry or ag commercial motor vehicle (Ag-CMV) in a no-passing zone?

Young Farmer and Agriculturist members from District 8 gathered on April 1 to enjoy a day of learning in central Wisconsin.

Our first tour was at H&S Manufacturing in Marshfield. We learned about the business history and building philosophies of H&S from tour host Ron Zygarlicke. We also enjoyed a tour of the manufacturing plant.

From there we went to the Marshfield Agricultural Research Station auditorium to listen to an insightful presentation from staff with the National Farm Medicine Center regarding farm safety topics and training. While there we enjoyed lunch sponsored by the National Farm Medicine Center and WFBF YFA.

Our next tour was Seehafer's Farm and Creamery in Marshfield. We learned about their agri-tourism venture in starting a creamery on-farm from Nikki Seehafer. Staff from the National Farm Medicine Center also presented some key points to consider when welcoming visitors on farm. Joey Ploeckelman gave a tour of the dairy farm and answered questions about milking practices, feed mixes and calf-heifer raising.

The last tour was at the UW-Marshfield Agricultural Research Station Farm in Stratford. Nancy Esser and Will Cordes presented the group with a lot of interesting information regarding what kinds of trials are conducted on UW research farms, why those trials take place and how dairy farms use and benefit from their findings.

Thank you to the tour hosts: H&S Manufacturing, Seehafer's and Marshfield Agricultural Research Station, the guest speaker from the National Farm Medicine Center and to everyone who participated in the tour. We hope you enjoyed the tour and found it informational.


