• Maintain funding for producer-led watershed grant program – consider increasing grants to \$1 million annually. (\$2 mil/bien)	• Producer-led Water Shed Grants: \$1 mil/ann; \$2 mil/bien
• Maintain funding and bonding for agricultural nonpoint source pollution program.	Nonpoint: Funding maintained
• Support to increase exportation of dairy products.	• Ag Exports: \$558,400mil/ann; \$1,116,800 mil/bien
• Support to increase funding of the Dairy Processor grant program.	• Dairy Processor Grants: \$400,000/ann; \$800,000/bien

• Provide funding to incentivize practices to protect groundwater This could include grants and funding for water stewardship certification, lake protection, soil and water conservation, or crop insurance premium rebates for cover crops.

Public Service Commission	
Support increased funding to expand broadband access and infrastructure.	• Broadband Grants: \$129 mil
University of Wisconsin System	
Maintain funding for the Dairy Innovation Hub.	• Dairy Innovation Hub: \$7.8 mil/ann
