More than 250 visited Madison to participate in Ag Day at the Capitol, as Governor Tony Evers and the Wisconsin state legislature were in the process of crafting the state's biennial budget which could top out at \$100 billion and includes a \$7 billion surplus.

District 2 members began their day with

networking and lunch at Monona Terrace Convention Center. They were updated on agricultural issues that Wisconsin farmers were experiencing.

March is a critical time for farmers to have their voices heard in Madison as the Wisconsin state legislature crafts the biennial budget. County Farm

further discussed and voted on at the county annual meeting. Suggestions and policy ideas move from the county level and are forward to the WFBF Annual Meeting where delegate members vote on the proposals. State WFBF leaders then forward policy to the national level that may impact federal legislation.

Our focus addresses legislative issues concerning the environment, taxes, trade, regulation, livestock, land use, health and safety, property rights, wildlife, and educational campaigns and programs such as Ag in the Classroom.

Leadership Institute Class 15 Participant

Session Two: People are Power

I find it difficult to ask for help. I think that's the culture across the field of agriculture – farm kids fix things themselves, right? But to do the best we can for our families, farms and communities... you've

got to have a team behind you.

In the second session of the Wisconsin Farm Bureau Leadership Institute, we focused on how to build and lead a team. Our class was split off into groups and were assigned books focused on leading a team and managing people. My partner and I read "You Don't Need a Title To Be A Leader" by Mark Sanborn. It was a quick and memorable read that I highly recommend!

One of the chapters was entirely focused on Power with People. Here's my takeaways for you to incorporate immediately into your day-to-day life:

- 1. **Be Trustworthy:** A leader must win followers through trust. But how does one become trustworthy?
 - a. If you don't know something, say so.
 - b. Don't make promises you can't keep.
 - c. Under promise and over-deliver.
 - d. Be careful to create realistic expectations.
- 2. Establish Connection: Effective leaders share bonds with
 - others and not because of their position or title. a. It can only happen if you are genuinely concerned
 - about others.b. It starts by being nice.
- 3. Ask For Help: "I need your help" is one of the most effective ways to motivate others.
 - a. It invites participation and shows the other person their opinion matters.
- Confront Problems, Not People: Confrontation is necessary. Avoiding conflict can lead to resentment. Here's how to do it:

 a. Show concern for the other person when addressing the problem.



- b. Solving a problem requires cooperation from the other person.
- c. Focus on correcting the behavior or action without judging.
- d. Talk about 'what' went wrong, not 'who'.

Session Three: Embracing the Media

I suppose this is a little bias coming from me (I work for the Mid-West Farm Report Radio Network), but I'm just as nervous with a microphone in my face as anyone else! I usually ask questions, not answer them. But if you don't talk to reporters... If you don't tell your side of the story... Then who will?

The third session with the Leadership Institute was all about how to effectively talk to the media.

American Farm Bureau Federation Senior Director of Media and Advocacy Training Johnna Miller came to Green Bay ready to make us sweat as she asked us the tough questions. She asked us, on video, what the average person is genuinely curious about: What does no-till mean? Isn't the Farm Bill just a welfare check for farmers? How do you stop cow farts from polluting the air?

These questions might surprise you, offend you or put you into a panic because you don't know

the best answer. Johnna and the Wisconsin Farm Bureau Federation team have great tips on how to be prepared for any media interaction: • Avoid farm jargon and

• Avoid farm jargon and acronyms.

- When answering questions, stay friendly, calm and confident.
- Do not 'wing it' or go on a tangent. Stick to your prepared statements.
- Do not get defensive.
- Speak in sound bites 8-10 second key messages that are digestible and to-the-point.
- Never agree to an interview or topic you are not comfortable with.
- Before the interview, take 15 minutes to review key messages and practice tough questions.
- Ask WFBF's public relations team to help you prepare.

Scholarship Deadline July 1



Are you a Dane County Farm Bureau member currently attending college and looking for a \$1,000 scholarship opportunity to help with your fall courses? Please review application criteria and

deadline date below:

- 1. Applicants or their parent(s)/guardian(s) must be a member of Dane County Farm Bureau.
- 2. Applicants must have completed one year of advanced education after high school before they apply. High school seniors are not eligible.
- 3. Preference will be given to applicants enrolled in an agriculture program.
- Applications must be completed in full and submitted by July 1. <u>Incomplete or applications</u> <u>submitted after July 1, may be disqualified.</u> Scholarship presentations will take place at the Dane County Farm Bureau annual meeting in September.
- 5. Applicants will need to submit proof of fall registration with this scholarship application.
- 6. Previous scholarship recipients cannot apply again for the scholarship.
- 7. Judges will use the following criteria for evaluation: Academics 50 percent; activities and awards 30 percent; and need 20 percent.
- 8. \$1,000 scholarship.



He then visited with farm owner Randy Hughes.

"This is a chance to show and tell them what it's like in the tractor seat, and to note the differences in our jobs," Hughes said. "For example, they aren't hired to be farmers, so we have to help them learn about agriculture; likewise, I'm not a governmental relations professional, so they have to help me learn about that. When they take their knowledge and combine it with what they learned in the field, everybody comes out on top."

Rural Mutual Insurance Agent Chris Hanna also rode with Wellnitz that day.

"This was a great experience and a lot of fun," Hanna said. "I'm on farms a lot to sell insurance but don't usually have the opportunity to ride along with farmers. Tim explained quite a bit about the planter and how it works and also about the organic beans he was planting."

Wellnitz was happy to see how genuinely interested both Hanna and Uken were in the operation.

"I would think this experience would help them with their specific jobs," he said. "It's good to at least get them out in the field to see how things work and gain some farming knowledge."

Uhe is pleased with the success of the day and the chance to help make connections and build relationships. She said she is excited about the opportunities for members to make an impact in Madison if they already have relationships with staff members.

"The staff was excited to meet our members, make connections and understand challenges members are facing in our area," she said. "I could see the passion the staff members had for their jobs and how the farmers helped give them a deeper connection to the work they're doing on behalf of the members. And I appreciate our members who took time during one of the busiest times of the year for this event."
